Upon review of the above comparison of the number of building permits issued, construction value and building permit fees collected generated in FY 2013/2014 versus FY 2012/2013 the following can be determined:

- 1.) The 391 building permits issued in FY 2013/2014 represents a 7% increase or 29 more building permits from the 362 building permits issued in FY 2012/2013.
- 2.) Construction value increased by \$2,465,340.08 from \$4,658,553.61 in FY 2012/2013 to \$7,123,893.69 in FY 2013/2014, or an increase of 35%. This significant increase in construction value is primarily due to large scale projects such as the Plowfield Square apartment, Timber Creek Assisted Living facility and the new Illinois American Water facility, but is also evidence that economic conditions appear to be improving in the City of Lincoln and property owners are making improvements to their properties that had been put off in years past.
- 3.) Given the increase in the number of building permits issued and a significant increase in construction value, resulted in a 73% increase in building permit fees from \$27,481.99 in FY 2012/2013 to \$100,236.45 in FY 2013/2014.
- 4.) Comparison of the attached Summary of Building Reports for FY 2012/2013 and FY 2013/2014 details the significant increase in new construction, but also provides further evidence that the level of reinvestment in-residential properties increased in FY 2013/2014, with a notable increase in the number of alteration permits.

CODE ENFORCEMENT ACTIVITY

Upon review of the above comparison of the number of ordinance violation letters generated during FY 2012/2013 versus FY 2013/2014 the following can be determined:

- 1.) During FY 2013/2014 the number of ordinance violations generated by the Building and Safety office slightly increased by 22 violation letters, representing an increase of 2 % from FY 2012/2013.
- 2.) While the overall number of violation letters generated by the Building and Safety office slightly increased, there was a significant decrease in the number of letters generated in March and April 2014, which is an indication that the condition and appearance of neighborhoods and properties throughout the city has shown marked improvement, as March and April have historically been months with a high volume of ordinance violation letters.
- 3.) Given the relatively high number of violation letters that continued to be generated in FY 2013/2014 provides evidence that the Building and Safety Department continues to be highly committed in identifying and bringing nonconforming properties into compliance with the requirements of the City Code.
